


COMPANY

The IE Group directors committee, management team and HR staff monitor compliance with this policy and convey it to business partners and stakeholders.



Everything we do, we do it to make this world a better place. We apply our knowledge, our skills and our creativity only for the good.





Footprint reducing technologies

Our radar solutions are developed to mitigate polluting operational activities. We reduce the need for test flights, reduce the required power for systems to operate performantly and reduce the number of tear and wear parts such as rotary joints and the requirements for lubrication.
